Seminars and Workshops

About the Institute

The University's Institute of Advanced Studies supports a programme of workshops and seminars that draw in scholars from around the world to discuss new research areas.

In 2004, the then Vice-Chancellor, Professor Dowling, agreed to provide £30,000 per year for three years from the University's Strategic Development Fund to launch the Institute of Advanced Studies. Funding was renewed in 2007 for another three years, thus allowing us to sustain workshops through into 2010. This year, the Institute will be asking the University to continue its support for a further period.

Each Autumn, bids have been invited from the university's academic staff for support for short workshops and seminars on leading edge subjects. The Institute's principal objectives in supporting these workshops are to attract international scholars to the University and to encourage new and productive research collaborations. The annual competition calls for bids that are multi-disciplinary, are likely to lead to significant advances, will attract international visitors, and are linked to current research at the University. Five awards of up to £5,000 each are made, conditional on matching funding being obtained from other sources. The Institute also pays an administrator, Mirela Dumic, for one day a week, who assists seminar organisers with arranging their workshops.

The first, pilot, workshop was held in April 2005 and the first competition was held in October 2005. Since then, the Institute has supported 27 workshops on topics that cover the disciplinary spectrum from Engineering to English. In addition to support from the Institute, sponsorship for the costs of the workshops has been obtained from Analyticon, the British Academy, BDO Stoy Hayward, EPSRC, European Commission, the International Council on Mining and Metals, London Mathematical Society, SciSys, QinetiQ, the UNEP/SETAC Life Cycle Initiative, Oxford Centre for Nonlinear PDE and many others. We thank these organisations for their support of our work.

Requests for the Institute's funds are judged by an Advisory Board consisting of Distinguished Professors: Alf Adams, Roland Clift, Greville Corbett, William Gelletly, Josef Kittler, Janet Lansdale (Emeritus) and Jim Lynch. The Institute is very grateful to them for their assistance in reviewing the bids. We expect to appoint new members to the Board in the coming year.

Seminars and Workshops

1. Modelling Urban Dynamics, April 2005

Professor Nigel Gilbert, University of Surrey and Dr Elizabeth Bruch, UCLA

Two papers first presented at this workshop were published in Sociological Methods and Research 1.2.

2. Microbial Systems Biology, July 2005

Professor Johnjoe McFadden, University of Surrey and Dr Claudio Avignone-Rossa, University of Surrey

A number of publications ^{3, 4, 5, 6, 7, 8, 9, 10, 11, 12} and grants totalling £1.3 million have been generated by research and collaborations after the workshop. One of these grants funded a second workshop on Microbial Systems Biology held in 2008 as part of a UK-Japan partnership funded by the BBSRC (Biotechnology and Biological Sciences Research Council).

This not only stimulated lots of lively discussion during the workshop but it provided new ideas that helped us to initiate several new projects in this field. 3. Theoretical Aspects Of Pattern Formation, September 2005

The outcome of this workshop was a research grant from Unilever PLC to the Centre for Research in Social Simulation worth £211,000 and a publication ¹³. A follow up workshop was held at the University of Groningen, the Netherlands, on 22 August 2007.

The workshop was attended by about 40 participants with world-wide coverage. In addition to the full report, a summary report ¹⁴ was produced. The workshop led to a meeting organised for UNEP in Copenhagen in July 2007, and to a follow-up workshop in Boston in September 2009.

The outcome of the Globalising Retail Workshop was an editorial for a theme issue of the Journal of Economic Geography ¹⁵, which contained a number of papers from the 1996 meeting.

11. Audio Description For Visually Impaired People, June 2007

Professor Margaret Rogers and Dr Sabine Braun (Centre for Translation Studies, University of Surrey)

A summary of the major outcomes of the seminar was published as a research overview article in a refereed journal ²⁵. An edited volume which includes selected papers from the seminar has been prepared. The outline for the volume was presented to Benjamins for their prestigious Benjamins Translation Library series. The manuscript is currently being prepared for submission.

Collaborations have been established with leading figures in the field of Audiovisual Translation, including Dr Aline Remael (Antwerp) and Dr Pilar Orero (Barcelona). As a result, Surrey has been invited to contribute to the EU project DTV4ALL, a project focusing on media access (including Audiodescription) and led by Pilar Orero (ongoing).

17. Investigating Sustainable Practice in Universities: Leading and Improving, September 2008 Centre for Environmental Strategy (CES) and Estates & Facilities Department of the University of Surrey

This practice-oriented conference which attracted almost 200 delegates has produced several outcomes:

- Dr Yacob Mulugetta wrote a sustainability position paper for discussion with the Vice Chancellor and Director of the Estates and Facilities. A new high level sustainability group has now been established. The group held its first meeting in early September 2009.
- Dr Yacob Mulugetta is editing a special issue on 'Low Carbon Communities' for Energy Policy. He is also writing a paper on 'low carbon pathway for Higher Education'. This will be a collaborative effort with University Sustainability Managers.
- In cooperation with Mr John Davis, the University's Sustainability Manager, 35 campus-wide student projects on sustainability issues have been run as part of the UG course on Sustainable Development. The event organisers also worked on another 10 student projects with three schools in Guildford.

18. Her Make Is Perfect: A Seminar Interrogating Women's Dramatic Writing, Text And Performance (1600-1830), September 2008

Professor Rachel Fensham (Dance Studies) and Professor Marion Wynne-Davies (Department of English)

The seminar, Her Make is Perfect, focussed on women and dramatic production in the seventeenth and eighteenth centuries. Part of the seminar was held at Chawton House. There have been three outcomes:

- The papers have been collected into a book proposal being edited by Churnjeet Mahn (Department of English), Kate Chisholm and Kate Napier. The proposal is currently with Ashgate.
- The seminar included performances by the GSA students; the students and their director, Kate Napier, went back to Chawton House and the performances were repeated and filmed. This DVD is currently being edited.
- The group of scholars at the seminar who worked on women writers rather than production decided to pursue and expand this element. Professor Marion Wynne-Davies (Department of English) applied for and was granted a fully-funded seminar slot at the Institute for English Studies at Senate House in London. These seminars will commence in January 2010. The seminar series is Early Modern Women's Drama, 1600-1800.

- A direct outcome of this was an accepted workshop proposal for the Biennial Conference of the Association for Linguistic Typology in July 2009 at the University of California, Berkeley.
- The commissioning editor for Linguistics at OUP expressed a strong interest in a volume resulting from the workshop and as a result, the manuscript for a book on Canonical Typology has been submitted to OUP, the first of its kind.
